NOTICE OF RACE

ORGANISING AUTHORITY:

The Open Belgian Championship Wingfoil Racing will be organised by:
Anemos Beachclub, under the authority of WWSV, BABC, BELGIAN SAILING and the IWSA.

LOCATION:

1 RULES

- 1.1. The regatta will be governed by the rules as defined in the Racing Rules of Sailing 2020-2024 (RRS), any amendments. https://www.racingrulesofsailing.org/rules?part_id=34
- 1.2. The BELGIAN SAILING prescriptions 2020-2024.
- 1.3. The IWSA class rules <https://wingfoilracing.com/>
- 1.4. The IWSA point system.
- 1.5. IWSA code of conduct.
- 1.6. This Notice of Race (NOR) and the Sailing Instructions (SI)
- 1.7. If there is a conflict between the Sailing Instructions and the Notice of Race, the Sailing Instructions shall prevail.
- 1.8. If there is a conflict between languages the English text will take precedence.

2 ADVERTISING

- 2.1. ISAF Regulation 20 – Advertising Code - shall apply.
- 2.2. Competitors may be required to carry advertising for event sponsors.

3 ELIGIBILITY

- 3.1. All competitors shall meet the requirements of ISAF Regulation 19.
- 3.2. All competitors shall be members of their National association, and their current year membership fees shall have been fully paid and verified.
- 3.3. Belgian competitors shall be 2024 member of a club and BABC member.

4 ENTRY and Pre-registration

- 4.1. Pre-registration is recommended, see * art. 16., or www.anemos.be
- 4.2. The regatta is open for International competitors.
- 4.2. Entryfee Wingfoil Racing €50 payment before 10 am first race day at Anemos Beachclub (clubhouse). Includes diner and drink at the price giving ceremony.
- 4.3. These championships shall be organised for next divisions:
 1. men Open Wing Foil
 2. women Open Wing Foil

4.4. A minimum of 8 entries is required to constitute a division. If the number of entries in a division reaches 16, that division may be given a separate start.

5 DAY SCHEDULE

6 EQUIPMENT Inspection

Equipment Inspection shall be conducted in accordance with IWSA.

7 SAILING INSTRUCTIONS

The Sailing Instructions will be available during registration at the Registration Desk.

8 VENUE

8.1. The competitors area will be located at Anemos Beachclub.

8.2. Racing area will be held on the North Sea, in front of the clubhouse

9 COURSE

The Championship shall use upwind/downwind courses.

10 PENALTY SYSTEM

10.1. Rule number 44 will apply during penalties at the time of an incident

11 SCORING

11.1. The Low Point System of Appendix A will apply.

11.2. 3 races must be completed with 8 starters to validate the Championship for each division.



12 SUPPORT BOATS

Team leaders, coaches and support personnel shall register during the registration at the registration office; and shall comply with the requirements in the Sailing Instructions.

13 RADIO COMMUNICATION

A boat shall neither make radio transmissions while racing nor receive radio communications not available to all boats. This restriction also applies to mobile telephones.

14 PRIZES

14.1 Trophies shall be awarded to the first 3 competitors in each properly constituted division.

14.2 Attendance at the prize giving ceremony is mandatory

15 DISCLAIMER OF LIABILITY

Competitors will sail at their own risk. The organising authority, and all parties involved in the regatta organisation will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the championship.

16 INSURANCE

Each racer shall have a current Public Liability and Third Party Property Insurance policy, including coverage when racing at the venue of the Championship, of not less than 1.500.000,00€ (or the equivalent).

17 RIGHT TO USE NAMES AND LIKENESS

By sailing this event a competitor automatically grants to the Organising Authority and the sponsors of the event the right in perpetuity to make, use and show from time to time and at their discretion, any motion or still pictures, and live, taped or film television and any other reproductions of him/her during the period of the Championship without compensation.

18 Drugs testing

18.1. Competitors are reminded of the ISAF rules and regulations concerning the use of banned methods and substances .
